

## CONDITIONS:

1. Environment should be kept free from mosquitoes breeding
2. Safe drinking water must be provided to all students and employees
3. All Children must have been vaccinated as per national immunization schedule and guidelines issued by government periodically.
4. All water storage containers and tanks should be kept tightly closed and maintained clean.
5. Septic tank Air pipe should be covered with mosquito net.
6. First aid box with necessary medicines should be kept ready for use.
7. Hall buildings should be constructed as per the plan approval enclosed with the application and submitted in this office.
8. No-objection certificate should be obtained from this office, if any alteration or modification in the existing building and additional building or new building is to be constructed.
9. Properly maintain fire safety equipment and educate the students & employees about its operation.
10. The institution premises must be kept neat and clean always.
11. Toilets and Urinals must be kept hygienically clean
12. There shall not be any thatched structure in the premises.
13. The building Maintain repairs should be done then and there immediately.
14. Basket for disposal of sanitary napkins should be provided in ladies toilets.
15. If any communicable disease or suspected disease is found among the school students in the premises, it must be immediately informed to the concerned PHC Medical Officer.
16. Sanitary certificate may be cancelled if any discrepancies or deviations are found in future during inspection.
17. A nodal teacher to be designated to line with local health authority for teaching preventive health actions like screening, deworming, vaccinations and other health related activities.
18. No smoking area " Smoking here is an offence " signage board to be displayed at prominent places as per COTPA, act 2003.
